





Our 2017/18 fiscal showed a growth in membership year over year with a positive outlook for 2018/19.



PROJECT SERVICES



- Total project amounts tendered was \$318,856,138 based on 237 projects posted in BidCentral.
- In our 2017/18 fiscal, there were 591 Premium Users in BidCentral, up 190% from 2016/17.
- In Spring 2018, we introduced our PreBid Report to complement our weekly eNews & Project Bulletin.

SPECIAL PROJECTS & MEDIA



- VICA's Construct Your Future program ran for two successful intakes in our 2017/18 fiscal with an 85% long-term employment rate; there are three more intakes under this grant carrying in to 2018/19.
- VICA received over 60 earned media mentions in 2017/18 and is poised to surpass that annual amount as indicated by a 305% increase in the first quarter of 2018/19 compared to the same period last fiscal.

VICA & NETWORK EVENTS



- In our 2017/18 fiscal, nearly 700 VICA members attended 10 events.
- In April 2018, VICA hosted its inaugural Vancouver Island Construction Conference with 250 delegates and announced the VICA Awards Gala to be held the evening before the 2019 Conference.
- In 2017/18, we engaged 1100+ individuals through 30 U40 & WiC events in Victoria & Nanaimo.

- VICA WiC Nanaimo raised \$1,340 for the Nanaimo Women's Centre.
- VICA U40 Victoria raised \$15,000 for the Help Fill A Dream Foundation.
- VICA's 2018 Christmas Luncheon raised \$10,000 for families in need.


VICA TRAINING & EDUCATION
